Regulation No.15.

This Regulation pertains to Six month Diploma/Six month Certificate Programs.

Name of the Program:

Six Month Diploma/Six Month Certificate

Eligibility for the Program

Every candidate seeking admission to the Six Month Diploma/Six Month Certificate shall have passed 10+2 examination with 45% marks in the relevant discipline of the Madhya Pradesh Madhyamika Shiksha Mandal or of any other statutory Central/State Board recognized as equivalent thereof. Additional admission requirements for respective course if any will be specified by the university from time to time.

Subject to the requirements of admission indicated above admission to the programme shall be on merit determined on the basis of entrance examination/procedure specified by the university from time to time. The number of seats, payment seats, reservation of seats etc shall be as per university guidelines from time to time.

Program Duration

The duration of the course of study for the Six Month diploma/Certificate will be a full time programme of six month. It shall extend over one semester in academic year. The course will commence in July every year. A candidate seeking admission in the program will be required to complete the course within a span of two academic years

Program Fees

The admission fee, tuition fee, examination fee and other fees shall be specified by the university from time to time.

Examination

The program shall consist of one semester and there shall be a university examination at the end of semester.

Provided that if a candidate fails in not more than one theory paper in semester examination but having passed in internal assessment examination of all papers shall be eligible to carry ATKT in the papers in which he has failed and to take examination of the ATKT papers along with the next identical semester examination only. He will be allowed to appear as ex-student in the next identical semester examination. The marks of internal assessment project shall be carried over.

If a candidate fails in internal assessment of even one paper he will be declared fail.

The course of study shall be as per the scheme provided in the prospectus. These will be subject to changes from time to time by the university.

The internal assessment shall consist of tests quizzes, assignments, presentations, attendance, lab work etc. Their relative composition will be decided/ notified by respective departments from time to time.

For passing the examination the candidates shall be required to secure at least 36% marks in each theory paper/practical/project and each internal assessment examination separately.

Candidates shall be awarded division on the basis of aggregate marks.

Minimum Pass Marks in each Paper (Theory) - 36%
Minimum Pass Marks in each Paper (Internal Assessment) - 36%
Minimum Pass Marks in Practical - 36%

The division shall be awarded as follows:

First Division :

60% or above of the aggregate marks.

Second Division

48% or above but less than 60% of the aggregate marks.

Pass

Less than 48% but 36% and above in aggregate.

Where ever not provided for in this Regulation, the general rules of the university shall be applicable, failing which the competent bodies of university shall have the authority to decide.
