Ordinance No. 113

LLM

1. The examination for the degree of Master of Law shall be held in two parts and each part shall consist of two Semesters as named below viz: -

LL.M. Part - I st	First Semester Examination
LL.M. Part - I st	Second Semester Examination
LL.M. Part - II nd	First Semester Examination
LL.M. Part - II nd	Second Semester Examination
2. The LL.M. class teaching shall start in July and January every year for the different semesters and the examination there of shall be held twice in a Year, namely, in December and May.
3. The candidates seeking admission to the LL.M. Degree course must have passed LL.B. 3 years or B.A.LL.B. 5 years course examination of this University or (other equivalent examination) of any recognized University. The admission shall be made in order of merit/ interview taken by the U.T.D. /Colleges and also as per Government / University Rules applicable to the courses.
4. The University shall decide the number of seats for University Teaching Department of Law and affiliated Colleges.
5. No candidate shall be permitted to appear in any of the LL.M. Semester examinations, unless he has attended at least 75% of the total number of lectures held during the semester session.
6. LL.M. Degree Course is a full time course. Hence an admitted student to the LL.M. degree course is not permitted to take admission in any other course leading to a Certificate or Diploma or Degree course.
7. That a candidate who wants to appear in LL.M. final examination of this University and who has passed LL.M. Previous Year Examination from any other University shall require to clear the remaining papers and Group of papers of this University.
8. All admission to LL.M. Previous or Final class must be completed in time as per University Rules/Govt. Rules. However if the result of LL.B. Final or LL.M. Previous is declared after admission date of this University than the admission must be completed within 10 days from the declaration of such result.
9. (a) In each paper the allocation of the marks shall be 100
(b) In order to be successful at semester examination a candidate must secure at least 40% in each paper and 50% of aggregate of grand total.

(c) Curriculum pattern and examination Scheme for the course shall be subject to approval of the concerned Board of studies / Faculty

Rules for Promotion to the Next semester:-

- (a) A candidate who has appeared in any semester of any particular year will be promoted to the next Semester of that year, irrespective of failing in any number of theory or practical examination. (That is from I to II and III to IV).
- (b) A candidate can not be allowed to carry any more papers than the paper of previous Semester of that year i.e. papers of I semester can be carried to II semester but not to the III semester. In the same manner papers of the III semester can be carried to IV semester.
- (c) The Examination of odd semester shall be held with the odd Semester and the Examinations of Even semester will take place with the even Semester. The backlog of the papers shall be completed in the related semester of that year.
- (d) The marks awarded to Practical examinations shall be carried forward to the subsequent examinations.
- (e) A candidate shall be treated as an Ex- Student in particular semester if the candidate has secured less than 40 marks in one or more papers of that semester, or if has failed in aggregate in that semester securing 40 or more marks in all the papers of the concerned semester examination.
- (f) The Ex-Student shall not be permitted to appear in any semester examination in which he has secured 50 marks or more for any purpose whatever.

11. Successful examinees of the L.L.M. part -II second semester examination shall be placed in a division on the basis of the total marks obtained by them in four semester examinations taken together as follows: -

- (a) Those securing 60% of marks or more shall be placed in First- Division, and.
- (b) Other successful candidates securing less than 60% shall be placed in Second -Division.


12. The candidate shall have the option to answer questions in English or Hindi medium.


13. A candidate may apply for revaluation of answer sheets, as per the university rules.

14. A candidate who has been declared unsuccessful in an examination may on his/her option reappear in subsequent examination as an Ex-Student without being required to attend regular course of study for the same semester subject to the condition that such a candidate shall abide by and be governed by the provisions of this and other ordinances, rules and regulations applicable time to time.

Ordinance No. 114
LLB (Three year Course)

- 1 The LL.B. course shall be a three year degree course (T.Y.D.C.) namely LL.B. First Year (I & II Semester), LL.B. Second Year (III & IV Semester) and LL.B. Final Year (V & VI Semester) and shall be of three year duration. All the colleges shall be whole time (day) colleges and the candidates will be full time regular students.
- 2 Candidates seeking admission to the LL.B. degree course must have passed degree examination from any recognized university and must have secured minimum percent of marks specified under the admission rules notified by the University.
- 3 The admission to the courses shall be through an entrance test or on merit.
- 4 Candidates for the LL.B. three-year degree course shall be required to pass six semester examinations, which shall be held in the month of December and May of each academic year.
- 5 Details of subjects to be taught during the courses, curriculum pattern and examination scheme for each semester course shall be subject to approval of the concerned Board of studies/ Faculty as per the guidelines of the Bar Council of India in this regard.
- 6 Students shall be required to put in a minimum attendance of 75% of the lectures on each of the subjects as also at tutorials, moot courts and practical training course. Provided that in exceptional cases for reasons to be recorded the Dean of the Faculty of Law and the Principal of Law Colleges may condone short of attendance required by the rule, if the student had attended 60% of the lectures in the aggregate for the semester examination as the case may be.
- 7 A candidate, who, after taking the Bachelor's degree of this University or of any other University recognized for this purpose, has completed a regular course of study of law in a constituent or an affiliated college of this University for an academic semester shall be eligible for appearing in that aforesaid examination.
- 8 Rules for promotion to the next semester and higher class of TYDC:
 - (i) From odd semester to even semester:
A candidate who has appeared in the odd- semester (Theory and Practical examination) of any particular year shall be promoted to an even semester of that year (i.e. from I to II from III to IV and from V

to VI semester), irrespective of failing in any number of theories and practical examination of that semester.

(ii) From even semester to odd semester:

A candidate shall be entitled to carry a backlog of papers for his promotion from even semester to odd semester of next academic sessions as under:

(a) A backlog of two papers (Theory and/ or practical) for his promotion from second semester of LL.B. first year to third semester of LL.B. second year.

(b) A backlog of four papers (Theory and /or Practical) (inclusive a backlog of two papers of LL.B. first year) for his promotion from fourth semester of LL.B. second year to fifth semester of LL.B. final/ third year.

(iv) A candidate shall be allowed to carry a particular semester if he has acquired minimum passing marks in all the papers (Theory/Practical) of that semester and has failed in aggregate by reason thereof. Such a candidate shall be allowed to reappear in semester examination in any number of papers of his choice in which he has acquired minimum passing marks in that semester in order to pass in aggregate in such semester examination but shall not be allowed to reappear in any paper (Theory/Practical) in which he has already acquired passing marks 50%

9 The examination of odd semester shall be held with the odd semester and the examination of even semester shall take place with the even semester.

10 Ex - students:

Subject to the general rule of promotion from odd semester to even semester, a candidate shall become ex-student of LL.B. first year, LL.B. second year and LL.B. third/final year as under:

(a) Ex - student in LL.B. First Year- if he carries a backlog of three or more papers (theory and/or Practical) in first and/or ~~fourth~~ ^{second} semester of LL.B. first year.

(b) Ex -student in LL.B. second year - if he carries a backlog of three or more papers (Theory and/or Practical) in third and/or fourth semester of LL.B. second year.

(c) Ex -student in LL.B. third/final year - if he carries a backlog of any paper (Theory and/or Practical) in fifth and sixth semester of LL.B. third/final year.

- (i) A candidate carrying a backlog of one or two papers, in LL.B. first year as a regular candidate at the time of examination of sixth semester of LL.B. third/final year shall be deemed to be an Ex-student on and after deceleration of his result of the said examination (till he passes the same within) the maximum limit of six year from the date of his initial/original admission in first semester of LL.B. first year of any academic year.
- (ii) A candidate carrying a backlog of four or less than four papers (inclusive of a backlog of one or two papers of LL.B.) first year in LL.B. second year as a regular candidate at the time of examination of sixth semester of LL.B. third/final year shall also be deemed to be an Ex-student at the time of examination of sixth semester of LL.B. third/final year shall also be deemed to be an Ex-student and after declaration of his result of the said examination (till he passes the same within the maximum limit of six years from the date of his initial/original admission in first semester of LL.B. first year of any academic year).
- (iii) A deemed Ex- candidate carrying a backlog of any papers(s) inclusive of backlog of any papers of LL.B. first year and/or LL.B. second year and/or an Ex-candidate carrying a backlog of any papers of LL.B. the papers within the maximum limit of six year from the date of his initial/original admission in first semester of LL.B. first year of any academic year.
- (iv) If the candidate fails to pass the backlog of papers within six years he shall cease to be a deemed ex-student and has to take new admission as a regular candidate of LL.B. first year, according to the rules applicable for the time being in force.
- (v) A candidate if fails in aggregate in any semester and carrying any semester by reason thereof in LL.B. first year, LL.B. second year and/or LL.B. third/final year or after the declaration of his result of sixth semester of LL.B. third/final year shall also be deemed to be an Ex-student. He shall be entitled to pass the backlog of semester for passing in aggregate within the maximum limit of six year from the date of his initial/original admission if first semester of LL.B. first year of any academic year. If he fails to pass the backlog of the semester by passing in aggregate, he shall cease to be a deemed ex-student and shall be required to take new admission as a regular candidate in LL.B. first year according to the rules applicable for the time being in force.

12 Revaluation of answer books shall be allowed as per provision of Ordinance No. 5.

13 If not provided otherwise the candidates will have to pass separately in written papers and practical, if any prescribed.

14 The minimum pass marks in each year's examination shall be 50 percent in the aggregate of all the papers and 40 marks in each individual paper. Division to successful candidates for the LL.B. degree will be assigned at the end of final year and law bases of merit obtained by him at the LL.B. first year, second year and final year examination i.e. all six semester as under:
First Division: 60 percent or above of the aggregate marks
Second Division: 50 percent or above of the aggregate marks

Note: Candidates who obtain 75 percent or more marks in the aggregate shall be declared to have passed the LL.B. degree course in the first division with distinction

15 For each paper there shall be lecture classes for at least 6 hours per week.

16 Candidates appearing for the LL.B. examination shall have the option of answering questions through the medium of Hindi (Devnagri Script) or English.

17 The provisions of the Ordinance on subject to changes/ amended in accordance with the directives of Bar Council of India and instruction issued by Department of Higher Education, Govt. of M.P. from time to time and adopted and notified by the University.

Ordinance No. 115
Ordinance for B.A.LL.B (Hons.) Degree
(Five year course)

1. The Degree of Bachelor of laws (BA. LL.B., (HONS)), shall comprise a course of study spread over a period of Five Academic years and the. candidates will be full time regular students.
2. THE ELIGIBILITY FOR ADMISSION SHALL BE AS FOLLOWS:
 - (a) At the time of joining the course of instruction in law, the person concerned has passed an examination in 10+2 or 11+ 1 course of schooling recognized by the educational authority of Central or State Governments or possesses; academic, qualifications are considered or Prevalent to 10+2 or 11+1 courses by the Bar Council of India.
 - b) Lateral entry would be permitted in Third Year of the Course to graduates and post-graduates in any discipline as prescribed by Bar Council of India after the entrance test depending on availability of seats and the number of such candidate should ordinarily not exceed 1/3 of the regular candidates.
 - (c) The candidate must have completed the age of 17 years at the time to admission.
 - (3) The admission to the course shall be through an entrance examination. Details shall be decided by the Executive Council from time to time.
 - (4) The Total number of seats shall be 60 for each year of the Course Out of these, unto 5 seats may be filled up for foreign students or N.R I. s. or students sponsored by N.R.I.s.
 - (5) The schedule of fee for the above, course shall be as under :-

Fee- For Indian Students (Including Tuition Fee)	General Rs 20,000/ per year
For. Foreign students and N.R I.s or students Sponsored by N.R.I.s.	U.S. 1,000/-

As the course is self-financed, the above fee is tentative and is subject to revision by the Executive Council for subsequent years from time to time.

Note : In addition to this, examination fee, enrolment fee and University miscellaneous fee payable by an U.T..D. student shall be payable as per rules in force-from to time.

A Candidate shall be eligible for the Degree of Bachelor of Laws, B.A. LL.B. (Hons.) when he has undergone the prescribed course of study for a period of not less than five years in the institution and has passed the requisite examination in all the subjects.
8. **REQUIREMENT FOR EXAMINATIONS AND ATTENDANCE :**
- (1) Examinations will be conducted by the vikram vishwavidyalaya, Ujjain in the months notified for other schools of Study as follows:

- (2) Examinations shall be in theory and practical training as stipulated.
- (3) A candidate will be permitted to appear for the examination only if:
- (a) The candidate has put in a minimum attendance of 66% of the lectures on each of the subjects also at the moot courts and practical training-course. Provided that in exceptional cases for reasons to be recorded and communicated to the Bar Council of India, the Dean of the Faculty of Law or the Head of the Institute may condone shortfall as required by this rule, if the student has attended 66% of the lectures in the aggregate for the semester or the annual examination as the case may be.
- (b) He obtains a certificate from the Head of the Institute of having satisfactorily completed the course of study prescribed in the subject and his conduct has been satisfactory.
9. The provisions of this ordinance in respect of requirements for examination, attendance, results and grades are subject to alteration from time to time and shall conform to guidelines and instructions of Bar Council of India.
10. "This ordinance shall be applicable in University Teaching Department as well as in affiliated colleges".

Ordinance No. 116
Ordinance for B.Com. LL.B (Hons.) Degree
(Five year course)

This ordinance shall be applicable in University teaching department as well as affiliated Colleges.

1. The Degree of Bachelor of Law (BBA. LL.B. (Hons) & B.Com. LL.B. (Hons) Shall comprise of a course of study spread over a period of five years and the candidates will be full time regular students. The five year course shall comprise two parts i.e. part - I, which will be a two year core programme of pre-law study and part-II which will be a three Year programme for professional training in law.
2. THE ELIGIBILITY FOR ADMISSION SHALL BE AS FOLLOWS;
 - (a) At the time of joining the course of instruction in law, the person concerned has to pass an examination in 10+2 course of schooling recognized by the educational authority of Central or State Government or posses academic qualification considered equivalent to 10+2 courses by the Bar Council of India.
 - (b) Lateral entry will be permitted in Third Year of the course to graduates of any discipline as prescribed by Bar Council of India after the entrance test depending on the availability of seats.
 - (c) The candidate must have completed the age of 17 Years at the time of admission. Maximum age for admission shall not be more than 22 years. (age of admission shall be subjected to approval of the concerned board of studies as per guidelines of B.C.I. in this regards.
3. The admission to the course shall be through an entrance examination/merit.
4. Details of subjects to be taught during the five years courses, curriculum pattern and examination scheme for each year course shall be subject to approval of the concerned Board of studies/Faculty as per the guidance of the Bar Council of India in this regard.

5. ELIGIBILITY FOR THE DEGREE :

(a) A Candidate shall be eligible for the degree for Bachelor of Laws, BBA. LL.B. (Hons) / B.Com.LL.B (Hons) When he has undergone the prescribed course of study for a period of not less than five years in the Institution and has passed the requisite examination in all the subjects.

(b) The students successfully completing first three years of B.A.LL.B. (Hons) will be awarded B.A.(Law) degree approval by the University. This degree will be equivalent to other graduation degree of the University. Such degree shall not entitle the student to enroll as an advocate.

6. The teaching shall start in July and January of every year and the Examinations there of shall be held twice a year ordinarily in the month of December and May.

7. A candidate will be permitted to appear for the examination only if he/she has put in a minimum attendance of 75% of the lectures on each of the subjects as also at the moot courts and practical training course.

8. PROMOTION RULES.

(a) A candidate shall not be admitted in the fifth or higher semester classes unless he/she has fully cleared the first and second semester examinations.

(b) A candidate shall not be admitted in the seventh or higher semester classes unless he/she fully cleared the third and fourth semester examinations.

(c) A candidate shall not be admitted in the ninth or higher semester classes unless he/she fully cleared the fifth and sixth semester examinations.

9. No candidate shall be declared to have cleared the final BBA. LL.B (Hons.) /B.Com LL.B. (Hons.) examination unless he/she has cleared the previous semesters. The results of the candidates who have cleared the tenth and final BBA. LL.B. (Hons)/B.Com. LL.B. (Hons.) Semester but

not the previous semester shall be withheld. He/she shall be deemed to have passed the final BBA, LL.B./B.Com LL.B. (Hons.) Examinations in the year in which he/she fully clears all the previous semester examinations.

10. The examination of odd semester shall be held with the odd semester and the examination of even semester shall take place with the even semester.
11. A candidate who has been declared unsuccessful in an examination may at his/her option reappear at it subsequently, as an ex-student without being required to attend regular course of study again for the same semester subject to the condition that such a candidate shall abide by and be governed by the provisions of this and other ordinances applicable.
12. (a) In order to be successful at a semester examination a candidate must secure at least 40% of marks in each paper and also at least 50% of aggregate of grand total.
(b) In each theory paper the allocation of marks shall be 80% on external assessment and 20% on internal assessment. The internal assessment for each subject shall be based on activities scheduled by the Department such as presentation, group discussion etc. along with regular attendance in library and class lectures.
(c) The marks for internal assessment shall be finalized by the department/college.
13. Those securing 60% marks or more shall be placed in Ist division and other successful examinees securing less than 60% marks shall be placed in IInd division.
14. The award of grace marks shall be as per University rules, applicable on other professional courses.
15. The provisions of the ordinance in respect of requirement for examination attendance results and grades are subject to alteration from time to time and shall conform to guidelines and instruction of Bar council India and Department of Higher Education Govt. of M.P.
