



TERMS AND CONDITIONS

1. The prescribed format of application and other required materials may be downloaded from Vikram University Ujjain website, www.vikramuniv.ac.in in A-4 size paper.
2. Benefit of reservation/Fee relaxation and other related relaxation can only be availed by candidates of MP domicile upon submission of caste, domicile, income (In case of non creamy layer(NCL)), Divyaang certificate issued by competent authority of Govt of MP.
 - a. A minimum of 55% marks(or an equivalent grade in a point-scale, wherever the grading system is followed) at the Master's level shall be the essential qualification for direct recruitment of teachers and other equivalent cadres at any level.
 - b. A relaxation of 5 % shall be allowed at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other backward Classes (OBC) (Non-creamy Layer)/Differently abled ((a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.
 - c. A relaxation of 5% shall be provided, (from 55%to 50% of the marks) to the Ph.D. Degree holders who have obtained their Master's Degree prior to 19 September, 1991.
3. The prescribed application fee is Rs 1000.00 for unreserved applicant/Rs 500.00 for SC/ST/OBC applicants of MP domicile on submission of supporting Certificate. SC/ST/OBC applicants of other states shall be treated as UR as per University/Govt of MP rules.
 - a. Applications in the prescribed form obtainable from the University Office, Madhav Bhawan, Kothi Road.Ujjain-456010 against Demand Draft Rs. 1000/- unreserved candidates and Rs. 500/- for SC/ST/OBC candidates drawn in favour of Registrar, Vikram University, Ujjain, payable at Ujjain, are invited for the following regular teaching posts in the University so as to reach the undersigned on or before dated 22-09-2021, duly completed. Fee once paid shall not be refunded in any circumstances.
 - b. Divyaang (D) candidates are fully exempted from payment of the prescribed fees on submission of relevant Disability Certificate issued by the competent authority.
 - c. In case the applicant wants to claim benefits under the Divyaang (D) category, the applicant's relevant disability should not be less than 40 per cent. Proof to this effect in the form of a valid Disability Certificate must be attached with the application.
6. Candidates are advised to satisfy themselves before applying that they possess at least the minimum essential qualifications and Academic/Research scores, furnished with clarity, as laid down in the advertisement.
7. Applications should be supported by **good quality photocopies of relevant documents (self attested)** in all respects. Claims of educational qualifications should be supported by Certificates/Mark sheets. Applications not supported by documents shall be summarily rejected.
8. The crucial date for reckoning possession of educational and other qualifications, possession of required experience, etc. is the last date of submission of application i.e 22/09/2021.
