

5. Applicants are advised to apply only if he/she fulfills the eligibility requirements. The responsibility of checking appropriate eligibility lies with the candidate.
6. Applicants must read and understand details given in the information brochure and Ordinance 11 & UGC regulation 2022 before filling the online application form. No written communication regarding Ph.D. admission session 2025-26 shall be provided. Applicants are advised to visit University website regularly for updates.
7. **Ph.D. Admission procedure (Session 2025-26)**
  - (i) Part 1 – Doctoral Entrance Test (DET) : It will be held for only those subjects in which NET exam is not conducted.
  - (ii) Candidates who have qualified in any 3 categories of UGC NET-
 

Category -1 : Eligible for (i) admission to Ph.D. with JRF and (ii) appointment as Assistant Professor.

Category - 2 : Eligible for (i) admission to Ph.D. without JRF and (ii) appointment as Assistant Professor.




Category - 3 : Eligible for admission to Ph.D. Programme only and not for the award of JRF or appointment as Assistant Professor.

The result of NET in percentile along with the marks obtained by a candidate to utilize the marks for admission to Ph.D.


The JRF-qualified students are admitted into the Ph.D. programme based on an interview as per the University Grants Commission (Minimum Standards and Procedures for Award of Ph.D. Degree) Regulations 2022.

For students who qualify in Categories 2 and 3 70% weightage will be given for test scores and 30% weightage for the interview for admission to Ph.D. programme. The Ph.D. admission will be based on the combined merit of NET marks and the marks obtained in the interview/viva voce.

The marks obtained in the NET by the candidates in Categories 2 and 3 will be valid for a period of one year for admission to Ph.D.

**How to Apply :**

- a. Interested applicants may apply through mponline website [Vikram.mponline.gov.in](http://Vikram.mponline.gov.in)
- b. Applicants can pay fee online through Mp-online authorized KIOSK.
- c. Applicant must upload his/her recent coloured photograph at the given space of the online application form. No other documents are to be uploaded.
- d. The name of the applicants must be the same as given in the marksheet/gradesheet of the 10<sup>th</sup> class.
- e. the information given in the online application form will be verified with the original documents at the time of interview. If it is found that an applicant has provided incorrect or false information or with held so irrelevant information at the time of filing up the online application form, the applicant shall be debarred from admission or admission can be cancelled at any stage during the course or study without giving prior notice.
8. The decision of the Samrat Vikramaditya Vishwavidyalaya, Ujjain regarding any dispute related to SVV Ph.D. Admission 2025-26 will be final and binding.
